HEREBY DECLARE THE FOLLOWING:

1. I declare that both the company I represent and that I myself shall respect and comply with any mandatory provisions of applicable national and international laws, including in particular those relating to job placement when carrying out my activities as an intermediary. In addition, I declare that both the company I represent and that I myself agree to be bound by the Statutes and regulations of HFF, as well as by the Statutes and regulations of FIFA in the context of carrying out my activities as an intermediary.
2. I declare that I am currently not a member of an executive committee/board of HFF, Regional Amateur Football Association, amateur club, professional club or any other legal entity that is a member of HFF, member of an HFF committee, player, referee and/or assistant referee, coach, instructor and am not head of technical, medical or administrative matters in FIFA, in a confederation, a member-association of FIFA, a Regional Amateur Football Association, amateur club, professional club or other legal

entity that is a member of HFF and official as set out under point 13 of the section of Definitions in FIFA Statutes, nor will I hold such a position in the foreseeable future.

3. I declare that I have an impeccable reputation and in particular confirm that no criminal sentence has ever been imposed upon me for a financial crime, a crime against corporate assets, property, a crime relevant to any falsification or a crime related to violence in any way whatsoever.
4. I declare that neither the company I represent nor I myself have any contractual relationship with regional amateur football associations and professional football associations, football associations, football confederations or FIFA, that could lead to a potential conflict of interest. In case of uncertainty, any relevant contract shall be disclosed. I also acknowledge that the company is precluded from implying, directly or indirectly, that such a contractual relationship with amateur football associations and professional football associations, football associations, football confederations or FIFA exists in connection with its activities as an intermediary.
5. I declare, pursuant to par. 4 art. 7 of the FIFA Regulations on Working with Intermediaries, that neither the company I represent nor I shall accept any payment to be made by a legal person to another legal person in connection with a transfer, such as transfer compensation, training compensation or solidarity contribution.
6. I declare, pursuant to par. 8 art. 7 of the FIFA Regulations on Working with Intermediaries, that neither the company I represent nor I shall not accept any payment from any party if the player concerned is a minor.
7. I declare that neither the company I represent nor I shall take part in, either directly or indirectly, or otherwise be associated with, betting, gambling, lotteries and similar events or transactions connected with football matches. I acknowledge that both the company I represent and I myself are forbidden from having stakes in or by employed by companies, concerns, organisations, etc. that promote, broker, arrange or conduct such events or transactions.
8. On behalf of the company I represent, I consent, pursuant to par 1 art. 6 of the FIFA Regulations on Working with Intermediaries, to HFF obtaining full details of any payment of whatsoever nature made to me by a club or a player for my services as an intermediary.
9. On behalf of the company I represent, I consent, pursuant to par. 1 art. 6 of the FIFA Regulations on Working with Intermediaries, to HFF, football associations, football confederations and FIFA obtaining, if necessary, for the purpose of their investigations, copies of all contracts, agreements and records in connection with the activities of the company as an intermediary. Equally, I consent to the aforementioned bodies obtaining any other relevant documentation from any other party advising, facilitating or taking any active part in the negotiations for which the company I represent is responsible.
10. On behalf of the company I represent, I consent, pursuant to par. 3 art. 6 of the FIFA Regulations on Working with Intermediaries, to HFF holding and processing any company data for the purpose of their publication.
11. On behalf of the company I represent, I consent, pursuant to par. 2 article 9 of the FIFA Regulations on Working with Intermediaries, to HFF publishing details of any disciplinary sanctions imposed or that may be imposed to the company I represent and informing FIFA accordingly.
12. On behalf of the company I represent, I consent to the fact that any dispute of this company with any persons, arising in the context of and following the implementation of the HFF Regulations on Working with Intermediaries, shall be referred in the last instance to the independent and impartial Court of Arbitration for Football of HFF.
13. Both the company I represent and I myself are fully aware and agree that this declaration shall be made available to the members of the competent bodies of HFF.
